Course Description

COURSE DESCRIPTION:

This course is devoted to the development of a longer piece of writing in any genre. Through this course, students will gain an understanding of the craft of writing by contextualizing one's work in the broader framework of culture, politics, and literary innovation. Collaborative critique and one-on-one meetings with the professor will help students develop their work. At the same time, extensive reading across genres will allow students to gain a better understanding of what it means to produce a book. Readings in philosophy, literature, art history, and film will form a part of the research that students undertake to inform their writing and extend their practice.

Course Learning Outcomes

The primary goal of this course is to provide a context for students to initiate and develop a significant body of work in a writing genre.

Students will learn provide critical responses and encourage creative progress of their peers.
Students will learn to present a writing project to their peers and articulate their aesthetic choices and goals

Attendance Policy

ATTENDANCE POLICY:

Students studying at The American University of Paris are expected to attend ALL scheduled classes, and in case of absence, should contact their professors to explain the situation. Covid-19 temporary amendments:

Students studying at The American University of Paris are STILL EXPECTED TO ATTEND ALL scheduled classes. Due to the Covid-19 pandemic, students will have the option of attending classes remotely when special circumstances apply. For example when students are placed under quarantine by the French authorities or by their doctor, or when students present symptoms of Covid-19 and are directed, by their doctor or the AUP Health Office, to remain home. It is still the student's responsibility to be aware of any specific attendance policy that their professor might have set in the course syllabus. In particular, Students attending remotely from distant Time Zones should check with their professors about the specific attendance policy for remote learners.

Attendance at all exams is mandatory.

In all cases of missed course meetings, the responsibility for communication with the professor, and for arranging to make up missed work, rests solely with the student.

Whether an absence is excused or not is ALWAYS up to the discretion of the professor or the department. Unexcused absences can result in a low or failing participation grade. In the case of excessive absences, it is up to the professor or the department to decide if the student will receive an "F" for the course. An instructor may also recommend that a student withdraw, if absences have made it impossible to continue in the course at a satisfactory level.

during the Drop/Add and Exam Periods.
