Course Description

COURSE DESCRIPTION:

What is 'feminism'? What does it mean to be a 'feminist' or to have a 'feminist perspective'? What is its relationship to gender and 'masculinity'? How does it respond to so-called 'anti-feminist' charges? Perhaps one of the most straightforward definitions is that provided by Indian feminist scholar Nivedita Menon, who claims that being a feminist is simply "to understand that different identities – located hierarchically as *dominant* or *subordinate* – are produced at different times and in different spaces, but also to be aware of the processes of gendering ... [that is], the ways in which people are produced as 'proper' men and women through rules and regulations of different sorts".

This course will examine these issues through a historically contextualized introduction to contemporary feminist theory. We will probe contemporary debates across a wide range of topics now felt to be of world-wide feminist interest: sexuality, masculinity, reproduction, production, writing, representation, culture, race and politics. The course aims to produce a challenging intellectual climate within which to explore the theorization of these issues across disciplines and cultures, and its relation to practice.

Course Learning Outcomes

To become familiar with a variety of feminist theorists and be able to articulate distinctions and resonances between their bodies of scholarship.

To be able to apply useful feminist tools in their thinking about real world problems and issues, in order to appreciate how elements of race, class, sexuality, ability, and gender interact.

To discover the tools of the digital humanities.

To think deeply about the material, political, economic, and cultural implications for the genesis of feminist theories and their applications in activism.

To explore one area of feminist theory that is of particular interest to them and become the class expert on this theorist/body of knowledge.

To appropriate feminist approaches in order to theorize themselves

To practice scholarly writing and research.

Attendance Policy

ATTENDANCE POLICY:

Students studying at The American University of Paris are expected to attend ALL scheduled classes, and in case of absence, should contact their professors to explain the situation. It is the student's responsibility to be aware of any specific attendance policy that a faculty member might have set in the course syllabus. The French Department, for example, has its own attendance policy, and students are responsible for compliance. Academic Affairs will excuse an absence for students' participation in study trips related to their courses.

Covid-19 temporary amendments:

Students studying at The American University of Paris are STILL EXPECTED TO ATTEND ALL scheduled classes. Due to the Covid-19 pandemic, students will have the option of attending classes remotely when special circumstances apply. For example when students are placed under quarantine by the French authorities or by their doctor, or when students present symptoms of Covid-19 and are directed, by their doctor or the AUP Health Office, to remain home. It is still the student's responsibility to be aware of any specific attendance policy that their professor might have set in the course syllabus. In particular, Students attending remotely from distant Time Zones should check with their professors about the specific attendance policy for remote learners.

Attendance at all exams is mandatory.

In all cases of missed course meetings, the responsibility for communication with the professor, and for arranging to make up missed work, rests solely with the student.

Whether an absence is excused or not is ALWAYS up to the discretion of the professor or the department. Unexcused absences can result in a low or failing participation grade. In the case of excessive absences, it is up to the professor or the department to decide if the student will receive an “F” for the course. An instructor may also recommend that a student withdraw, if absences have made it impossible to continue in the course at a satisfactory level.

Students must be mindful of this policy when making their travel arrangements, and *especially during the Drop/Add and Exam Periods*.

ENGLISH LANGUAGE PROFICIENCY STATEMENT: As an Anglophone university, The American University of Paris is strongly committed to effective English language mastery at the undergraduate level. Most courses require scholarly research and formal written and oral presentations in English, and AUP students are expected to strive to achieve excellence in these domains as part of their course work. To that end, professors include English proficiency among the criteria in student evaluation, often referring students to the university Writing Lab where they may obtain help on specific academic assignments.
