Course Description

Shortly after its launch in the 7th century CE, the Islamic religion quickly rose and became a great power in the Middle East. It was in these early years that Islamic Art developed and coalesced into a definitive style. By looking at early monuments such as the Dome of the Rock and the Great Mosque of Damascus, this class will explore the ways in which the rulers of the first Islamic empires combined existing artistic styles with new elements to develop what we now identify as Islamic Art. The class will also discover how the precepts of Islamic belief affected early Islamic Art, and the ways in which the early Islamic rulers used art and architecture to express their authority.

Starting in the 13th century, the Mongol invasions brought Chinese influence to the Islamic world, transforming both its art and its society. The period from 1400 to 1800 saw the rise of many of the great Islamic empires: the Timurids in Central Asia, the Safavids in Iran, the Mughals in India, and the Ottomans in Anatolia. The art of this period, from the miniatures of the Safavid court to elaborate Mughal tombs such as the Taj Mahal, reflects the wealth and power of these great empires as well as a strong identity that can be traced back to the earliest days of Islam.

Islamic Art is dynamic and multifaceted, and we will explore painting, sculpture, and architecture, as well as portable arts including textiles, ceramics, ivory, metalwork, and illuminated manuscripts. Thematically, we will engage with topics such as the uses of figural and non-figural imagery, calligraphy and ornament, religious and secular art, public and private art, the art of the court, and the meaning(s) of the portable arts. We will also consider how trade, diplomacy, political influence and the arts linked the West, the Middle East and East Asia together, establishing Islamic art as a fertile intersection of cross-cultural influence.

Attendance Policy

AUP ATTENDANCE POLICY:

Students studying at The American University of Paris are expected to attend ALL scheduled

classes, and in case of absence, should contact their professors to explain the situation. It is the student's responsibility to be aware of any specific attendance policy that a faculty member might have set in the course syllabus. The French Department, for example, has its own attendance policy, and students are responsible for compliance. Academic Affairs will excuse an absence for students' participation in study trips related to their courses.

Covid-19 temporary amendments:

Students studying at The American University of Paris are still expected to attend ALL scheduled classes. Due to the Covid-19 pandemic, students will have the option of attending classes remotely when special circumstances apply. For example, when students are placed under quarantine by the French authorities or by their doctor, or when students present symptoms of Covid-19 and are directed, by their doctor or the AUP Health Office, to remain home. It is still the student's responsibility to be aware of any specific attendance policy that their professor might have set in the course syllabus. In particular, Students attending remotely from distant Time Zones should check with their professors about the specific attendance policy for remote learners.

Attendance at all exams is mandatory. In all cases of missed course meetings, the responsibility for communication with the professor, and for arranging to make up missed work, rests solely with the student.

Whether an absence is excused or not is ALWAYS up to the discretion of the professor or the department. Unexcused absences can result in a low or failing participation grade. In the case of excessive absences, it is up to the professor or the department to decide if the student will receive an "F" for the course. An instructor may also recommend that a student withdraw, if absences have made it impossible to continue in the course at a satisfactory level.

The days we go to the museums and monuments we will use the longer class time on Fridays (periods 3 and 4) to ensure that everyone has enough time to get there and back without missing any other classes. We will not need the extra period if there are video replacements of the visits.

Important note on the readings: you will be expected to submit ~300-word reflections on THREE articles in blue font by the time of the midterm, and the same thing for the final on the 'Student Notebook' section of TEAMS. Instructions can be found at the end of the syllabus, so that you can get started ahead of time. This will be counted as part of your exam grades. I will give you full credit for the reflections if it is clear that you read the articles. I will only deduct points if they are full of errors or if it seems that you did not read them.
